1. I confirm that the information in this entry form and the information and my acceptance of the terms of my competition licence are correct.
2. I confirm that I understand the nature of the competition I am entering and I am competent to take part.
3. I confirm that any vehicle I use will comply with the regulations and will be safe and fit for use in competition.
4. Before taking part in the event I will ensure (unless prohibited) that I have inspected the venue, the track, and the facilities and geographical features and that I am satisfied that it is safe to compete.
5. I will not take part if I have any doubt about my ability or the safety of the venue.
6. I accept that the competition in motorsport may involve the risk of injury or death and I agree to take part at my own risk.
7. Before taking part in the event I will read and be bound by and comply with the general regulations, any supplements and final instructions issued by the AMCA, the organisers, the circuit owners and the regulatory body.
8. I will not participate whilst under the influence of alcohol or intoxicating drugs and that if I am taking any prescribed medication I will inform the event organiser and seek approval before taking part.
9. If under the age of 18, my parent/guardian has read the above and signed the declaration and agreement below.
